I hereby declare that:

1. I accept the bicycle, all the elements of which it is made up and, when applicable, the helmet, which are provided to me as a loan for use. I therefore assume the exclusive responsibility thereon until the time of return and I undertake to return them in the same condition in which I received them. Likewise, I undertake to return the bicycle, all of its components and the helmet within the period of time provided for such return at any of the stations.
2. I accept the full and complete liability for any injury to myself resulting from the use of the bicycle as well as for any damage caused to third parties.
3. In the event of the crime of unlawful appropriation, as provided for in section 173(2), Argentine Criminal Code, or if the bicycle provided to me were returned with a damaged frame owing to misuse, the Government of the City of Buenos Aires shall be entitled to enforce the loan for use agreement, with this document constituting an affidavit. In that case, I shall be charged a fine of ARS 1,500. The amount of such fine may be modified every year and users are free to check such changes in the user manual available at <http://mejorenbici.buenosaires.gob.ar/sistema-de-transporte->

publico-en- bicicletas/inscripcion/. Should I choose to pay over the applicable fine voluntarily, I shall be entitled to a 50% discount. In this case, I shall send an e-mail through the website <http://mejorenbici.buenosaires.gob.ar/sistema-de-transporte-publico-en-bicicletas/consultas/> indicating '*pago voluntario*' in the subject and disclosing my first and last name, ID type and number, address and cellular phone number in the e-mail.

4. I accept that failure to meet the obligations undertaken shall give rise to the following penalties, regardless of any further legal consequences arising from my actions:
 - Users shall not be allowed to use the bicycles of the Public Bicycle Transportation System for 1 (one) week the first time a bicycle and/or helmet are returned after the time set (one hour); for 1 (one) month, the second time; for 2 (two) months the third time, and they shall be permanently banned from using the bicycles if they fail to return a bicycle in due time a fourth time.
 - Users shall be permanently banned from using the bicycles of the Public Bicycle Transportation System if they fail to return them or if they return the bicycles with a damaged frame resulting from misuse. Users shall be reinstated upon payment of the related fine.
 - Users shall not be allowed to use the bicycles of the Public Bicycle Transportation System for 1 (one) month the first time a bicycle is returned with broken parts (other than the frame) resulting from misuse or the helmet delivered as a loan for use is not returned; they shall be banned for 2 (two) months the second time; for 3 (three) months the third time; and they shall be permanently banned from using the bicycles if they fail to return a bicycle in due time a fourth time.
 - Users reported to have disregarded road traffic safety regulations 3 (three) or more times shall be permanently banned from using the bicycles of the Public Bicycle Transportation System.
